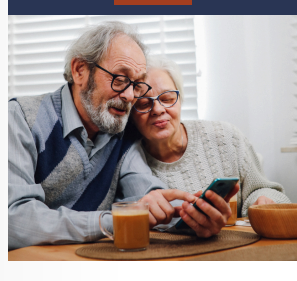

Who is eligible under the Legal Service Plan?

You and your eligible dependents are covered by the New York Labor Health Care Alliance, Inc. (herein as the "Union"). Your "eligible dependents" include:



- Your legal spouse who resides with you.
- Your registered domestic partner.
- Your unmarried dependent children from birth to their nineteenth birthday. This includes any child who: (1) normally resides in your household in a parent-child relationship; and (2) is legally dependent upon you for support and maintenance.
- *Note: Eligibility is extended to age 26 if your unmarried children are dependent upon you for support and enrolled as full-time students in an institution of higher education.
