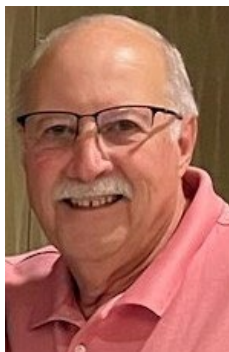

He remains the Chairman and a trustee to the Local 1822 trust funds to this day.
